Travel & Hotel Information:

Hotel check-in for Delegates is Sunday, June 14, 2026. Check-out will be Thursday, June 18, 2026.

Deadline for hotel room reservations is Friday, May 15, 2026 – NO EXTENSION OF THIS DATE!

Checks will not be accepted at check-in. To pay via check, please coordinate with Katherine at the regional office before check-in.
