# NY UAW Priorities 2024

#### S5085B/A4066 (Kennedy/Burgos) Fully Compensate Warranty Services

This bill will fully compensate warranty services for workers who repair cars under manufacturer's warranty. Currently, the workers only make one quarter of what they work on a car not under warranty. This bill rectifies this and allows workers to be paid fully for each hour of work they work. This bill would impact all warranty techs across the state, unionized and nonunionized. It will bring in \$900 million into New York's economy rather than going to the corporations as they currently are.

#### S541A/A1893 (Hoylman-Sigal/Joyner) Empire Act

The EMPIRE Worker Protection Act would significantly increase the state's capacity to enforce labor standards and critical workers' rights protections by creating a mechanism that allows private individuals to bring whistleblower lawsuits on behalf of the State. It will bring in \$103 million to the State's coffers.

### S4402/A1443 (Kennedy/Wallace) Shorten Unemployment for Striking Workers from Two to One Week.

This bill would rectify the waiting period, plus two week wait, that make it three weeks before striking workers can collect unemployment, and make it the two weeks as was initially intended by the 2019 bill that passed. It would also bring New York State even with New Jersey for the duration of wait time.

# S4511/A1568C (Ramos/Simon) Student Loan Forgiveness for Legal Services

This bill would allow legal services workers to have student loans forgiven. This would apply to both prosecutorial side, and defense side workers. It would follow the precedent set by the nurses having this provision and would cost an estimated \$4 Million to the state.

#### S2821A/A4053A (Ramos/Solages) Paid Medical Leave Reform

Strengthen Paid Medical Leave in New York. This bill provides New Yorkers with meaningful medical leave; currently, if workers need to take time off of work to care for their own serious medical needs, they are only entitled to \$170/week of unprotected leave and are not guaranteed their health insurance during a medical crisis. This bill provides a progressive wage replacement model that ensures that lower wage workers are getting meaningful compensation if/when they need to take time off of work. The bill also makes minor changes to paid family leave to add a more inclusive family definition and shorten the waiting period.



#### S7590/A7897 (Rivera/Paulin) NY Health Act

This Bill will create a single-payer, universal healthcare system for New York State.

#### OTHER TOPICS ALREADY DEEMED TO BE STATE PRIORITIES FOR 2024

#### **Unemployment Reform**

We will be working on reforming the unemployment system in New York. We will be taking up all the causes in the Worker Justice Package about unemployment specifically. While we will support all the bills in this package, we will focus on the shortening the wait time bill as our priority.

#### **Workers Compensation Reform**

We will be working on reforming the workers compensation system in New York. Building on the bill Hochul signed into law this year we will be seeking greater allocations to workers who are temporarily unable to work, ensuring they get their full amount they can.

#### FORTHCOMING BILLS ALREADY DEEMED TO BE STATE PRIORITIES FOR 2024

#### **Union Made in NY Flowchart**

This will be a bill that will create a flowchart for procurement in New York State highlighting union made labor, local hiring, made in USA provisions, and more.

#### **Property Tax Freeze for Seniors**

This will be a bill to support senior citizens who own property and give them incentive to stay in New York State.
